## **MORIN M-85 LICENSE AGREEMENT**

## PLANS SERIAL NUMBER:

### WARNING: READ CAREFULLY. IN THIS AGREEMENT, THE PURCHASER AGREES TO ASSUME ALL RISKS ASSOCIATED WITH THE CONSTRUCTION AND FLYING OF THE MORIN M-85 AIRCRAFT

1/ For and in consideration of the sum of \_\_\_\_\_\_€, Jean-Charles Duccini, 8 rue Despujols, 33000 Bordeaux (www.campavia.com), owner of the original plans and world marketing and fabricating rights of the Morin M-85 aircraft, hereinafter referred to as Seller, does agree to extend the right to build one Morin M-85 aircraft only and for his own use to:

hereinafter referred to as Purchaser

Seller further agrees to supply one set of construction plans of the Morin M-85. The plans supplied with this license agreement remain the property of the Seller. The aircraft serial number is the one of the plans.

2/Purchaser agrees that he will not allow another party the use of these plans to build a second airplane, will not allow these plans to be duplicated or copied in any way (including scan), and will not transfer these plans to another party without the written approval of Jean-Charles Duccini.

3/This agreement does not include the right to construct and produce completed M-85 aircraft for sale, which rights are expressly excluded from this agreement.

4/Purchaser agrees to build the aircraft following recognized aircraft construction practice and in accordance to the specification set forth in the plans. Purchaser declares that he is qualified to build, test and fly the M-85 aircraft or if not qualified, that he will obtain qualified assistance and instruction.

5/For a period of two years from the date of this agreement, Seller agrees to promptly notify the Purchaser of any change in the design or noticed defect in which the airworthiness, safety or structural integrity might be a factor. If any additional drawings are issued, they will be charged to Purchaser.

6/Purchaser agrees to notify promptly of any design defect, structural failure, or any other factor adversely affecting the safety, structural integrity or airworthiness of the aircraft.

7/ Purchaser agrees and understand (a) that Seller makes no warranty, expressed or implied, as to the quality, safety, structural integrity or airworthiness of the aircraft to be assembled pursuant to this agreement or that the aircraft once built is able to be licensed by any governmental authority, (b) that the aircraft so assembled will be operated entirely at the risk of the Purchaser, (c) that the Purchaser specifically assumes all risks arising out of the construction, operation or use of the Morin M-85 aircraft and hold Jean-Charles Duccini and André Morin, designer, totally and completely harmless from any legal liability. All subsequent buyers, heirs, successors or assigns are also bound by all terms of this agreement.
